

2024 Scholarship Application

DESCRIPTION

The First Service Foundation scholarship is available to graduating high schools seniors who plan on pursuing an associates or bachelors degree at an accredited college or university. Applicants from high schools in the following counties are eligible to apply for the First Service Foundation scholarships: *Franklin, Fairfield, Delaware, Union, Licking, Pickaway, Madison and Morrow.* The recipient will be awarded a \$2,000 non-renewable scholarship that will be paid directly to the university the recipient attends. The recipient understands that the scholarship must be used for the 2024/2025 academic year; and if it is not used by that date, the scholarship is forfeited. Students will be selected based on the information the Foundation Scholarship Committee receives from all eligible applicants.

Deadline for application is Tuesday, April 30, 2024.
